LIABILITY GUIDELINES

I understand that use of the facilities and equipment at The Salvation Army Kroc Center may involve risk of bodily injury or property damage and I agree to assume any such risks. I understand that it is up to me to consult physicians and other professionals to make sure that I can safely participate in activities and events at The Salvation Army Kroc Center. I also understand and agree that by signing this agreement, I am giving up my right (and/or the right of the minor(s) for whom I sign) to make any claim against The Salvation Army Kroc Center, its agents, employees and volunteers, including the right to sue them, for bodily injury or property damage or any other loss that I might suffer while using The Salvation Army Kroc Center facilities and services, except as limited by law. If The Salvation Army has actual knowledge that an individual is a registered sex offender, such individual shall be denied access to the Ray and Joan Kroc Corps Community Center (RJKCCC). By signature on this document, I represent to The Salvation Army, that neither I, nor any of my guests, which may from time to time attend the RJKCCC are registered sex offenders in any legal jurisdiction and that furthermore, I have an affirmative duty to The Salvation Army to immediately disclose to The Salvation Army any change in registered sex offender status for myself or any of my guests who may from time to time seek admittance at the RJKCCC.

POLICIES, PROCEDURES, RULES AND REGULATIONS

EVENT INFORMATION INITIALS _____

- A parent/legal guardian must sign a waiver for each individual under 18.
- Refreshments will be served after exiting the pool. No Exceptions.
- You are welcome to bring your own cake and refreshments from a licensed food vendor. i.e. Wal-Mart, Pizza Hut. Food from a non-commercial kitchen is prohibited.
- Helium balloons, glitter, confetti, liquid string, real rose petals, etc. are not allowed.
- Bubble machines and smoke machines are not allowed on the premises.

POOL POLICIES INITIALS _____

- For children under the age 8, the ratio must be 1 adult to 3 children in the pool. For children over the age of 8, the ratio is 1 adult per 6 children in the pool.
- Children must be 48" tall to ride the large water slide.
- Personal items should be locked in a locker. The Kroc Center is not responsible for any lost and/or stolen items.
- All infants are required to wear a swim diaper AND plastic leak-proof pants over the diaper.
- All patrons must wear proper swim attire, NO street clothes, cotton clothing, undergarments or athletic wear permitted. Anyone not wearing a swimsuit will not be permitted to swim.
- In the event of a storm with lightening, the large water slide and hot tub will close.
- In the event of an emergency pool closure due to cleaning, your party will be rescheduled or refunded within three business days. If possible, alternate accommodations may be made the day of the party.
- Pool is open to our Members during party times.
- Please bring your own towels. There is a rental fee for the use of Kroc Center towels.
- No photography allowed in pool or locker room areas. Photos may be taken in party room.
- Running and horseplay is not permitted in or out of the water.
- Gum, food, glass containers, alcohol, and tobacco products are not permitted in the pool area or locker rooms.
- State regulations require patrons to shower before entering the pool. Lifeguards may ask patrons to shower at any time.
- The Kroc Center operates as a Recreation Water Park therefore we maintain the pool water temperature between 82 and 86 degrees Fahrenheit.
